AN EMERGENCY ORDINANCE

Authorizing the Director of Capital Projects to apply to the District One Public Works Integrating Committee for state funding for constructing improvements to portions of State Route 283 (East 55th Street) and St. Clair Avenue; to apply for and accept any gifts or grants for this purpose from any public or private entity; authorizing professional services, agreements with public and private entities, and any relative agreements; and authorizing the Commissioner of Purchases and Supplies to acquire, accept, and record for right-of-way purposes any real property and easements necessary to make the improvement.

WHEREAS, under Article VIII, Section 2k of the Ohio Constitution, the State of Ohio is authorized to issue bonds and other obligations of the State for the purpose of financing public infrastructure capital improvements of political subdivisions as designated by law; and

WHEREAS, under Sections 164.03 and 164.04 of the Revised Code, the District One Public Works Integrating Committee has been created to evaluate applications for state financing of capital improvement projects of local subdivisions in Cuyahoga County; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Capital Projects is authorized to apply to the District One Public Works Integrating Committee for state funding for the following infrastructure capital improvement: rehabilitating State Route 283 (East 55th Street) from Superior Avenue to St. Clair Avenue and St. Clair Avenue from East 55th Street to East 72nd Street (the "Improvement").

Section 2. That the Director of Capital Projects is authorized to apply to the District One Public Works Integrating Committee for state funding in the form of a loan or grant, or a combination of both, to obtain credit enhancements and loan assistance in support of the city's bonds issued for bridge and road improvements for the Improvement.

Section 3. That the Director of Finance, or other appropriate Director, is authorized to accept one or more loans or grants from the Ohio Public Works

Commission to finance the Improvement; that the Director of Finance, or other

appropriate Director, is authorized to file all papers and execute all documents necessary to receive the funds under the loan or grant; and that the funds are appropriated for the purposes described in this ordinance.

Section 4. That the Director of Capital Projects is authorized to employ by contract or contracts one or more consultants or one or more firms of consultants for the purpose of supplementing the regularly employed staff of the several departments of the City of Cleveland in order to provide professional services necessary to implement the Improvement.

The selection of the consultants for the services shall be made by the Board of Control on the nomination of the Director of Capital Projects from a list of qualified consultants available for employment as may be determined after a full and complete canvass by the Director of Capital Projects for the purpose of compiling a list. The compensation to be paid for the services shall be fixed by the Board of Control. The contract or contracts shall be prepared by the Director of Law, approved by the Director of Capital Projects and certified by the Director of Finance.

<u>Section 5.</u> That the Director of Capital Projects is authorized to enter into one or more agreements with private utility companies to pay charges for the installation of underground lines in connection with the Improvement.

Section 6. That, when appropriate, the Director of Capital Projects is authorized to enter into one or more contracts with the railroads, Greater Cleveland Regional Transit Authority, the Northeast Ohio Regional Sewer District and other entities to obtain services or to acquire property rights such as easements and licenses, necessary to construct the Improvement.

Section 7. That the Director of Capital Projects is authorized to apply for and accept any gifts or grants for the Improvement from any public or private entity; and that the Director is authorized to file all papers and execute all documents necessary to receive the funds; and that the funds are appropriated for the purposes described in this ordinance.

<u>Section 8.</u> That the Director of Capital Projects is authorized to accept cash contributions from public or private entities, for infrastructure costs associated with the

Improvement. That the Director of Capital Projects is authorized to enter into

agreements with the entities for this purpose.

Section 9. That the Director of Capital Projects is authorized to enter into any

agreements necessary to implement this ordinance.

Section 10. That notwithstanding any provision of the Codified Ordinances of

Cleveland, Ohio, 1976, to the contrary, the Commissioner of Purchases and Supplies is

authorized to acquire, accept, and record for right-of-way purposes any real property

including but not limited to gift, fee simple acquisitions, temporary easements,

permanent easements, and work agreements as is necessary to make the Improvement.

The consideration to be paid for the property and easements shall not exceed fair

market value, as determined by the Board of Control.

Section 11. That the Director of Capital Projects is authorized to execute on

behalf of the City all documents necessary to acquire, accept, and record the property

and easements and to employ and pay all fees for title companies, surveys, escrows,

appraisers, and all other costs necessary for the acquisition of the property and

easements.

Section 12. That the Clerk of Council is authorized and directed to transmit to

the State three (3) certified copies of this ordinance immediately on its taking effect, and

it shall become the basis for proceeding with the Improvement.

Section 13. That the cost of this ordinance shall be paid from Fund Nos. 20 SF

568, 20 SF 574, 20 SF 579, 20 SF 586, 20 SF 592, 20 SF 597, 20 SF 702, 20 SF 712, 20

SF 718, the fund or funds to which are credited any gift accepted, loan or grant proceeds

received under this ordinance, future bond funds if issued for this purpose, cash

contributions accepted under this ordinance, and from any other funds approved by the

Director of Finance. (RQS 0103, RLA 2023-86)

Section 14. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to

Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period

allowed by law.
