WHEREAS, this Council wishes to withdraw its objection to the above permit and consents to said permit; and

WHEREAS, this resolution constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That objection to the transfer of ownership of a D5 and D6 Liquor Permit to Ohio City Nails, LLC, DBA Gaia Nail Lounge & Spa, 1870 West 25th Street & Mezzanines, Cleveland, Ohio 44113, Permit No. 6516315 by Resolution No. 260-2023, containing such objection, be and the same is hereby repealed and that this Council consents to the immediate permit thereof.

<u>Section 2</u>. That this resolution is hereby declared to be an emergency measure and provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
