# Ordinance No. 1233-2023

#### AN EMERGENCY ORDINANCE

To amend Section 9 of Ordinance No. 371-2022, passed May 16, 2022, relating to conducting the Exterior Paint Program.

# By Council Members Hairston and Griffin (by departmental request)

WHEREAS, under Ordinance No. 371-2022, passed May 16, 2022, this Council authorized the Director of Community Development to conduct the Exterior Paint Program; and

WHEREAS, the Exterior Paint Program provides a valuable incentive to homeowners and tenants to maintain the exterior of their home and aid in reducing lead-based-paint hazards; and

WHEREAS, the Director of Community Development wishes to use additional pre-encumbered funds for the Exterior Paint Program; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Section 9 of Ordinance No. 371-2022, passed May 16, 2022, is amended to read as follows:

<u>Section 9.</u> That the written agreements, standard purchase, and/or requirement contracts may not exceed \$1,568,044.00 \$2,110,792.00 and will be paid from Fund No. 01-8006-6463, RQS 8006, RL 2022-41 and RQS 8006, RE 2020-1802.

Section 2. That existing Section 9 of Ordinance No. 371-2022, passed May 16, 2022, is repealed.

Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
