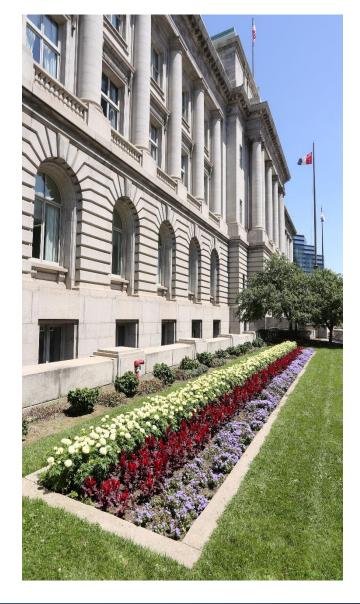

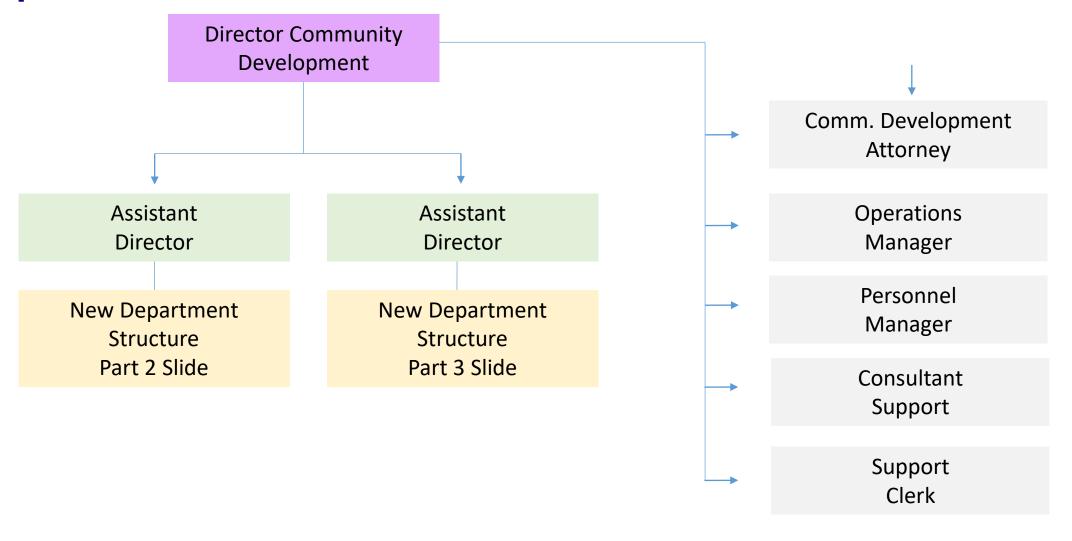

PROTECT PRESERVE PRODUCE POSITION

- **Protect 35,600 housing units** through equitable affordability interventions, including down payment assistance, affordable home loans, renter protections and legal aid, rental assistance, and property tax exemptions.
- Preserve 41,400 housing units through housing quality interventions, including home repair assistance, small landlord loans, and compassionate code enforcement.
- Produce 23,000 housing units through new construction or substantial rehabilitation supported by targeted development incentives, revised zoning, and streamlined approval processes.

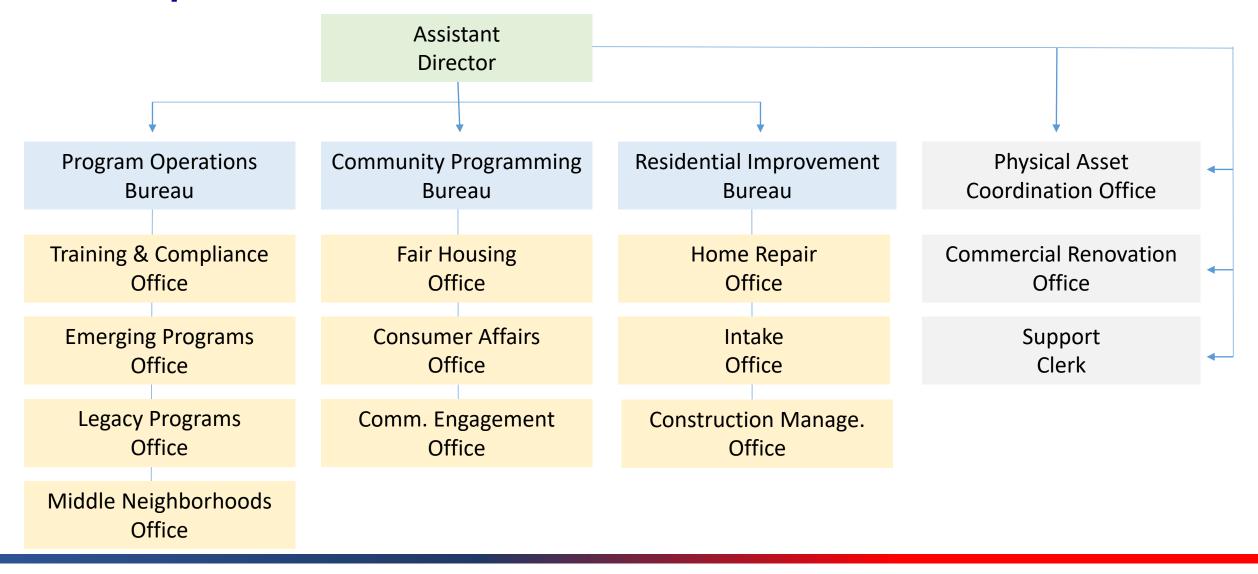


New Department Structure- Part 1



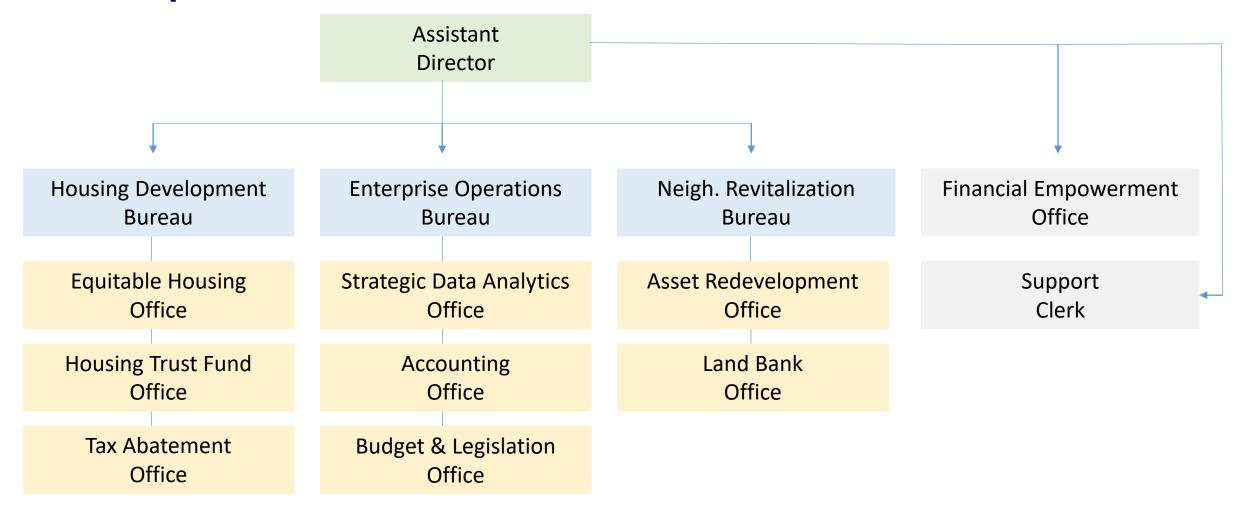


New Department Structure- Part 2

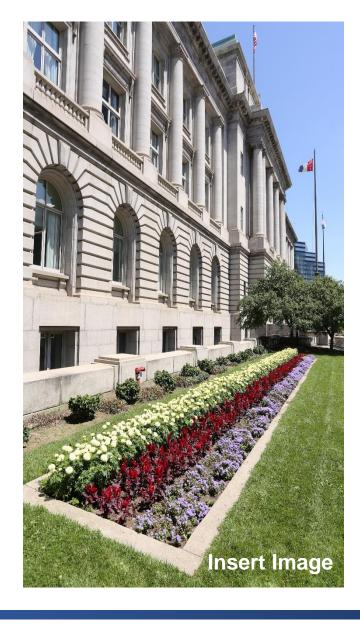

Reforming Approach- Universal Application

Universal Residential Application

Replaces multiple application intake points and provides residents one access point where needs are matched with resources to address home repair, home rehab and other household needs

Universal Developer Application

Replace RFP specific applications, to enable the processing of market rate and affordable development projects.

Universal Partner Application

One application to replace the Social Services, Citywides, CDC and Departmental partnerships RFP processes
