# **Ordinance No. 1371-2023**

#### AN EMERGENCY ORDINANCE

To amend the grant agreement entered into under Ordinance No. 753-2021, passed September 20, 2021, as amended, relating to applying for and accepting a grant from the Cleveland Foundation for the development of the African American Cultural Gardens.

WHEREAS, under Ordinance No. 753-2021, passed September 20, 2021, as amended by Ordinance No. 1189-2021, passed February 14, 2022, this Council authorized the Director of Public Works to apply for and accept a grant from the Cleveland Foundation for the phase two construction and donor engagement for the African American Cultural Garden at 890 Martin Luther King Jr. Drive, Cleveland, Ohio, within the Cleveland Cultural Gardens; and

WHEREAS, the Director of Public Works desires to extend the term of the grant to December 31, 2024; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Public Works is authorized to accept the April 3, 2023, grant extension letter from the Cleveland Foundation, that extends the grant period from April 1, 2023 to December 31, 2024, for donor engagement and the phase two construction of the African American Cultural Garden. All other terms and conditions of the grant agreement entered into under Ordinance No. 753-2021, as amended, shall remain the same.

Section 2. That the grant extension letter contained in **File No. 1371-2023- A**, which is made a part of this ordinance as if fully rewritten, is approved in all respects.

Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
