AN EMERGENCY ORDINANCE

To amend Section 1 of Ordinance No. 1034-2023, passed September 18, 2023, relating to a First Amendment to Agreement with iVideo for Cleveland City Council.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

<u>Section 1.</u> That Section 1 of Ordinance No. 1034-2023, passed September 18, 2023, is amended to read as follows:

Section 1. That the Clerk of Council is authorized to enter into an amendment to the agreement with iVideo, City Contract CT 1511-PS2023*0110 CT 0101 PS 2023*0110 to authorize additional professional services necessary for the design, implementation and permanent installation of various components of the video production system to include the Mercedes Cotner Committee Room. The cost of all additional services under this amendment shall not exceed \$20,783.00 and shall be paid for from fund C19025 and C21031.

<u>Section 2.</u> That existing Section 1 of Ordinance No. 1034-2023, passed September 18, 2023 is hereby repealed.

Section 3. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
