#### AN EMERGENCY ORDINANCE

Amending Section 1 of Ordinance No. 271-2024, passed March 4, 2024, authorizing the Director of the Department of Public Works to enter into an agreement with the Cleveland Cultural Gardens Federation for the 2023 One World Day Expo.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore

### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Section 1 of Ordinance No. 271-2024, passed March 4, 2024 is amended to read as follows:

<u>Section 1.</u> That the Director of Public Works is authorized to enter into agreement effective as of August 1, 2023, for the One World Day Expo for the public purpose of providing educational programming, and activities, and other supportive services including security and transportation, on the diverse ethnic population and various cultures that are present in the City of Cleveland.

Section 2. That the existing Section 1 of Ordinance No. 271-2024, passed March 4, 2024 is repealed.

Section 3. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
