## Ordinance No. 1269-2023

By Council Members Hairston, Bishop and Griffin (by departmental request)

### **AN EMERGENCY ORDINANCE**

Authorizing the Director of Capital Projects to enter into one or more agreements with the City of East Cleveland regarding the public improvement of resurfacing Woodworth Avenue between Hayden Avenue to Coit Road, to among other items, allow East Cleveland to make the public improvement of resurfacing the portions on Woodworth Avenue which are located in the City of Cleveland; and to cause payment to the City of East Cleveland for the City's portion of the improvement.

WHEREAS, the City of East Cleveland will be making the public improvement of resurfacing Woodworth Avenue between Hayden Avenue to Coit Road ("East Cleveland Resurfacing Project") which will include portions located in the City of Cleveland; and

WHEREAS, in order to ensure a seamless border between East Cleveland and Cleveland, the City of Cleveland desires to partner with the City of East Cleveland to allow East Cleveland to include the Cleveland portion in the East Cleveland Resurfacing Project; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Capital Projects is authorized to enter into one or more agreements with the City of East Cleveland to, among other items, allow East Cleveland to make the public improvement of resurfacing the portions of the East Cleveland Resurfacing Project which are located in the City of Cleveland.

Section 2. That this Council authorizes payment to the City of East Cleveland of the City of Cleveland's share for the portion of the East Cleveland Resurfacing Project, located in the City of Cleveland, from Fund Nos. 20 SF 568, 20 SF 574, 20 SF 579, 20 SF 586, 20 SF 592, 20 SF 597, 20 SF 702, 20 SF 712, 20 SF 718, and from the fund or funds to which are credited the proceeds from the sale of any future bonds, if issued for this purpose, and other funds approved by the Director of Finance. (RQS 0103, RLA 2023-104)

Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
