AN EMERGENCY ORDINANCE

Authorizing the Director of Economic
Development to enter into a development
agreement with Cleveland LD LLC, or its
designee, successors and assignees, to plan and
execute a development and finance strategy to
maximize public and private use along
Cleveland's riverfront, including Tower City,
property between Huron Road and the riverfront,
and property between Ontario Street and the
riverfront.

WHEREAS, the City of Cleveland (the "City") desires to enter into a development agreement (the "Agreement") with Cleveland LD LLC, or its designee, successors and assignees ("Bedrock") to plan, and execute a development and finance strategy to maximize public and private use along Cleveland's riverfront, including Tower City, property between Huron Road and the riverfront, and property between Ontario Street and the riverfront, to be more fully described in the Agreement (the "Project");

WHEREAS, the Project is aligned with and advances the City's goals and objectives for the Central Business District and is expected to result in a significant and substantial influx of public and private investment in the City and its residents, including the creation of additional jobs, tourism, development, and revenues; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That notwithstanding and as an exception to any section of the Codified Ordinances of Cleveland, Ohio, 1976, to the contrary, the Director of Economic Development is authorized to enter into the Agreement, for and on behalf of the City, with Bedrock to plan, and execute a development and finance strategy for the Project. The Agreement shall replace and take precedence over any prior development agreements between Bedrock or its affiliate Bedrock Management Services LLC, and the City relating to the subject matter hereof.

<u>Section 2.</u> That the Agreement authorized by this ordinance shall be prepared by the Director of Law and approved and certified by the Director of Finance.

<u>Section 3.</u> That each of the Directors of Finance and Law, and other appropriate City officials, are authorized to execute, for and on behalf of the City, any other documents, agreement, instruments or certificates and take any other action as may be necessary or appropriate to carry out the terms of the Agreement and this ordinance.

<u>Section 4.</u> That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
