Marmel Pub, LLC, DBA M & M's Saloon, 12524 Lorain Avenue, 1st floor and basement, Cleveland, Ohio 44111, Permit No. 5546767 be and the same is hereby withdrawn and Resolution No. 851-2019, containing such objection, be and the same is hereby repealed and that this Council consents to the immediate permit thereof.

That this resolution is hereby declared to be an emergency measure Section 2. and provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
