A Brief Biography

Jay served in the Cleveland City Council beginning in 1980 and retired at the end of a term in 2013. From 1990 – 1999 Jay was President of the Council. Jay worked with the Council to set goals for service and develop a mission statement that guided the council for several terms. Jay focused on the creation of Cleveland's first recycling program and he concentrated on community vitality, community policing, enhanced community development work and youth violence prevention.

Prior to being elected to Cleveland City Council, Jay was a VISTA Supervisor for the Cleveland Legal Aid Society. While there, Jay developed a program of tenant outreach promoting tenant rights and healthy food, provided through a public housing food co-op.


Throughout his life, Jay has been guided by a firm belief in the ability of dedicated citizens to build a wholesome democratic society. From starting block clubs, citizen's organizations like community development organizations, to campaign committees, Jay works to put his beliefs into action. He is a founder of the original Ohio Public Interest Campaign, now called Ohio Citizen Action. The organization is a statewide organization working to advance citizens organizing to gain equal rights for all.

Jay and his wife Helen married for 46 years and have two daughters who grew up in homes on the west side of Cleveland in a ward that stretched from Edgewater Park to Brooklyn. Both daughters are married and live in Cleveland. Jay and Helen have two grandchildren ages 3 and 6. Since moving to the Shaker Square area, the grandparents and grandchildren are less than a block apart.

In the neighborhood, Jay is involved with civic activity including "Save Shaker Square," a housing stabilization initiative called the Morelands Group, a part of the Shaker Square Alliance, and headed a project of the Western Reserve Land Conservancy. This program focused on neighborhood stabilization through blight removal and vacant land conversion to vibrant green space. Jay works along with Council Member Deborah Gray and neighboring Council Member and Council President Blaine Griffin.

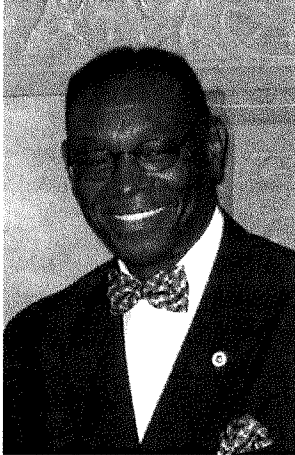

Minister Roland Muhammad has distinguished himself in the Greater Cleveland Community as a businessman, community activist and spiritual leader.

He is the owner of Shabazz Bakery, a distribution company for his signature baked goods. He is President of Brothers Investment Group 6, Inc (B.I.G. 6, Inc.), working to develop business plans to support the needs of Cleveland neighborhoods and he most recently founded P.O.W.E.R LLC, (People Organized Working for Economic Rebirth LLC) creating a business association to address the redevelopment of communities.

Previously, Minister Muhammad was the founder and general manager of Blue Seas Fish House and Bakery, a Cleveland neighborhood restaurant that was in business for over 18 years - employing many within this timeframe. During this time, he served as Treasurer of the Ward 5 Community Congress and President of the Longwood Merchants Association.
