Description: Obsolete Ordinances

Staff recently discovered certain pieces of legislation in a file box that are roughly 10 or more years old (2008-2013). It appears that, for various reasons, the City Planning Commission never took action on any of these pieces. For that reason and the age of the legislation, these ordinances are obsolete for our purposes and therefore are being returned to City Council. The Ordinance Numbers are as follows (with brief descriptions):

JPB

Ordinance No. 945-08 (Councilmember Sweeney): To amend Section 350.10 of the Codified Ordinances of Cleveland, Ohio, 1976, as amended by Ordinance No. 1282-06, passed November 27, 2006, relating to billboards.

JPB

Ordinance No. 1257-08 (Councilmembers Kelley, Cimperman, and Sweeney – by departmental request): Authorizing the Director of Port Control to solicit proposals from qualified firms to undertake the management, design, and development of aviation and non-aviation related services at selected Department of Port Control or City-owned properties and related facilities consistent with the Airport's Master Plan and to enter into one or more leases or leases by way of concession for a term of thirty years with two ten-year options to renew subject to additional legislative approval.

Resolution No. 1619-08 (Councilmembers Santiago, Brady, Cimperman, and Sweeney – by request): Declaring the intent to vacate a portion of West 29<sup>th</sup> Street.

JPB

Ordinance No. 15-10 (Councilmember Polensek): Rescinding the landmark designation of St. Joseph Christian Life Center on Lakeshore Boulevard.

JPB

Ordinance No. 731-10 (Councilmember Cimperman): Changing the Use District of lands on the southeast corner of Literary Road and W. 5<sup>th</sup> Street shown shaded to RA2 Townhouse.

JPB

Ordinance No. 735-10 (Councilmember Cimperman): Changing the Use District of lands on the northwest and northeast corners of Kenilworth and Literary Avenues at W. 11<sup>th</sup> St. to Local Retail Business.

JPB

Ordinance No. 736-10 (Councilmember Cimperman): Changing the Use and Area Districts of lands on the south side of Starkweather Ave. between Saint Tickon St. and Saint Olga St to Two-Family Residential and a 'B' Area District.

JPB

Ordinance No. 738-10 (Councilmember Cleveland): Changing the Use District of land located at the northeast corner of Woodland Ave. and E. 75<sup>th</sup> St. to Open Space and Recreation.

JPB

Ordinance No. 753-10 (Councilmember Mitchell): Changing the Use, Area and Height Districts of lands located on the southeast corner of Notre Dame Avenue and Mount Carmel Road to a Two-Family Residential District, a 'B' Area District and a '1' Height District.

JPB

Ordinance No. 1080-13 (Councilmember Cimperman): Establishing a Pedestrian Retail Overlay Special Sign District (PRO-S) on lands located on the northwest and southwest sides of Professor Avenue between West 10<sup>th</sup> Street and Jefferson Avenue; including lands along College Avenue and Jefferson Avenue between Tremont Street and W. 7<sup>th</sup> Street.

Ordinance No. 1081-13 (Councilmember Cimperman): Establishing a Pedestrian Retail Overlay Special Sign District (PRO-S) on lands located along W. 14<sup>th</sup> Street, Starkweather Avenue and Auburn Avenue.

JPB

Ordinance No. 1082-13 (Councilmember Cimperman): Establishing a Pedestrian Retail Overlay Special Sign District (PRO-S) on lands located at the intersection of Fairfield Avenue and West 11<sup>th</sup> Street.

JPB

Ordinance No. 1083-13 (Councilmember Cimperman): Establishing a Pedestrian Retail Overlay Special Sign District (PRO-S) on lands located at the intersection of Kenilworth Avenue, Literary Road and West 11<sup>th</sup> Street.

JPB

Ordinance No. 1084-2013): Establishing a Pedestrian Retail Overlay Special Sign District (PRO-S) on lands located at the intersection of Professor Avenue and Starkweather Avenue.
