AN EMERGENCY ORDINANCE

Authorizing the Director of Building and Housing to employ one or more professional consultants, computer software developers, and/or vendors to implement the E-Plan and Software Project; and authorizing the purchase by one or more contracts of materials, equipment, supplies and services needed to furnish and remodel the offices of Building and Housing to implement the project.

WHEREAS, the Department of Building and Housing desires to implement their E-Plan and Software Project (the "Project") which will upgrade their offices and technical systems from a paper-based submission of plan documents to an electronic receipt of design documents, plans, and specifications to streamline their processes and improve customer service; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Building and Housing is authorized to employ by contract or contract one or more consultants, computer software developers, and/or vendors or one or more firms of consultants, computer software developers, and/or vendors for the purpose of supplementing the regularly employed staff of the several departments of the City of Cleveland to acquire one or more software licenses, upgrades to existing software, other software needs, and for other professional services necessary for project management, business analysis, software implementation and configuration, end user and technical staff training, enhancements, and other related professional services needed to implement the Project.

The selection of the consultants, computer software developers, and/or vendors or one or more firms of consultants, computer software developers, and/or vendors shall be made by the Board of Control on the nomination of the Director of Building and Housing from a list of qualified consultants available for employment as may be determined after a full and complete canvass by the Director of Building and Housing for the purpose of compiling a list. The compensation to be paid for the services shall

be fixed by the Board of Control. The contract or contracts authorized shall be

prepared by the Director of Law, approved by the Director of Building and Housing, and

certified by the Director of Finance.

That the Director of Building and Housing is authorized to make Section 2.

one or more written contracts under the Charter and the Codified Ordinances of

Cleveland, Ohio, 1976, for each or all of the following items: materials, equipment,

supplies, and services necessary to upgrade and remodel the offices of Building and

Housing, and for the purchase of furniture, computers, peripherals, and other related

equipment and services needed to implement the Project, to be purchased by the

Commissioner of Purchases and Supplies on a unit basis, for the Department of Building

and Housing.

That under Section 108(b) of the Charter, the purchases authorized Section 3.

by this ordinance may be made through cooperative arrangements with other

governmental agencies. The Director of Building and Housing may sign all documents

that are necessary to make the purchases, and may enter into one or more contracts

with the vendors selected through that cooperative process.

That the cost of the contract or contracts authorized shall be paid Section 4.

from Fund Nos. 01-8501-6926, 20 SF 566, and other funds approved by the Director of

Finance, Request No. RQS 8501, RL 2017-94.

Section 5. That this ordinance is declared to be an emergency measure and,

provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval

by the Mayor; otherwise it shall take effect and be in force from and after the earliest

period allowed by law.
