#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Section 50 of Ordinance No. 194-2021, passed March 29,

2021, as amended by Ordinance No. 243-2021, passed April 19, 2021, Ordinance No.

494-2022, passed June 6, 2022, Ordinance No. 1061-2022, passed November 7, 2022

and Ordinance No. 506-2023, passed May 8, 2023, Ordinance No. 177-2025, passed

March 3, 2025 is amended to read as follows:

<u>Section 50.</u> <u>Municipal Court Employees.</u> That salaries and compensation in the following classifications shall be fixed by the appointing authority in accordance with the schedule appearing after each classification:

That existing Section 50 of Ordinance No. 194-2021, passed March 29, 2021, as amended by Ordinance No. 243-2021, passed April 19, 2021, Ordinance No. 494-2022, passed June 6, 2022, Ordinance No. 1061-2022, passed November 7, 2022, Ordinance No. 506-2023, passed May 8, 2023, and Ordinance No. 177-2025, passed March 3, 2025, is repealed.

<u>Section 3.</u> That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
