2021 Temporary Budget Assumptions and Notes

Personnel Costs

- 1. 26 Payroll Cycle Employees (Full Time, Part-time, Seasonal, etc.): January through March 2021.
- 2. Longevity: Longevity is included at 100%. The payout is completed March 31, so the entire budgeted amount is included in the Temporary Budget.
- 3. Separation: Approximately 25% of anticipated separation costs are included in the Temporary Budget. In cases where we knew specific divisions would have higher separation costs in the first three months than would normally occur, adjustments were made.
- 4. Hospitalization, Prescription, Dental, Vision, Life: The Temporary Budget includes funding covering payments made from January through March of 2021.
- 5. PERS: The Temporary Budget includes funding to cover the first quarter, or 25% of PERS charges.
- 6. Police and Fire Pension: Funds are included to cover the first quarter, or 25% of pension obligation.
- 7. FICA/Medicare: Funds are included to cover three (3) months worth of expenses.
- 8. Workers Compensation: Payments to BWC are not processed until May, therefore there are no funds included in the Temporary Budget for this line item.
- 9. Unemployment Compensation: 40% of the annual appropriation level included in the Temporary Budget.
- 10. Clothing Allowance and Clothing Maintenance: Payouts for these items are mandated under union contracts to occur in March; therefore, 100% of the estimated annual budget is included in the Temporary.
- 11. 2021 will include the new department of Health Equity and Social Justice.

Other Expenses: The default used in creating the Temporary Budget was to load 40% of the estimated budget in all line items below the line, i.e. contractual, materials and supplies, interdepartmental service charges. Adjustments were made to divisions that require full certification of major contracts in the first quarter.
