

Ordinance No. 302-2021

AN EMERGENCY ORDINANCE

To amend Sections 48 and 49 of Ordinance No. 194-2021, passed March 29, 2021, as amended, relating to compensation for various classifications.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Sections 48 and 49 of Ordinance No. 194-2021, passed March 29, 2021, as amended, are amended to read as follows:

Section 48. Hourly Rate - Cleveland Building and Construction Trades Council
Compensation for all persons employed by the hour in any of the following classifications shall be fixed by the appointing authority within the limits established in the following schedule for each classification:

Section 49. Hourly Rate – MCEO.

Effective May 1, 2021, compensation for all persons employed by the hour in any of the following classifications shall be fixed by the appointing authority within the limits established in the following schedule for each classification:

Section 2. That existing Sections 48 and 49 of Ordinance No. 194-2021, passed March 29, 2021, as amended, are repealed.

Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
