AN EMERGENCY ORDINANCE

Authorizing the Directors of Public Works and Finance to enter into agreement to enter into one or more contracts with the Cleveland Metropolitan School District to conduct educational, recreational and extracurricular programming through the use of Ward 13 Neighborhood Capital Funds, Neighborhood Equity Funds, Casino Revenue Funds and Neighborhood Development Funds.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Directors of the Departments of Public Works and Finance to enter into agreement effective August 1, 2017 with the Cleveland Metropolitan School District to conduct educational, recreational and extracurricular programming for the public purpose of providing educational activities to city of Cleveland youth through the use of Neighborhood Capital Funds, Neighborhood Equity Funds, Casino Revenue Funds and Neighborhood Development Funds.

Section 2. That the cost of said contract shall be in an amount not to exceed \$316,000 and shall be paid from Fund No. 10 SF 166, Fund No. 10 SF. 177, Fund No. 10 SF 188, and Fund 14 SF 042.

<u>Section 3.</u> That the Director of Law shall prepare and approve said contract and that the contract shall contain such terms and provisions as he deems necessary to protect the City's interest.

<u>Section 4.</u> That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
