

Ordinance No. 331-2021

AN EMERGENCY ORDINANCE

To amend Section 2 of Ordinance No 708-17, passed July 12, 2017, as amended, relating to a grant from the Ohio Office of Criminal Justice Services for the 2016 Ohio Drug Law Enforcement Fund grant program.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Section 2 of Ordinance No. 708-17, passed July 12, 2017, as amended by Ordinance No. 1375-17, passed December 4, 2017, is amended to read as follows:

Section 2. That the application for the grant, File No. 708-17-A, made a part of this ordinance as if fully rewritten, as presented to the Finance Committee of this Council at the public hearing on this legislation, including the obligation of the City of Cleveland to provide cash matching funds in the amount of \$142,536.21 from Fund No. ~~10 SF 026~~ 10 SF 025, is approved in all respects and shall not be changed without additional legislative authority. (RQS 6001, RL-2017-51 and RQS 6001, RL 2017-97)

Section 2. That existing Section 2 of Ordinance No. 708-17, passed July 12, 2017, as amended by Ordinance No. 1375-17, passed December 4, 2017, is repealed.

Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
