Request for Legislation

An ordinance to authorize the Department of Public Utilities (DPU) to enter into one or more contracts with Oracle to provide professional consulting services for the Hosting and Managed Services associated with Oracle Customer Care and Billing (CC&B) system, meters, applications, maintenance, licensing, and related products. Legislation is to lead to a contract or contracts for the term of one year with two one-year options to renew, exercisable by the Director of Public Utilities.

Background/Purpose:

DPU is requesting to enter into one or more contracts with Oracle in order to provide hosting, professional services, managed services, maintenance, software, cloud computing, and any other related services and products required to manage DPU CC&B. This system manages customer billing, meter reading, meter inventory, customer appointments, and related reporting. It is also integrated with several systems including Automated Meter Reading (AMR), bill printing, electronic bill presentment, payment, and cashiering.

Scope of Work/Commodities/Services:

All servers that are used to operate the CC&B system will be maintained by Oracle at their primary secured data center. Oracle will also provide and manage a disaster recovery site at a secondary data center location. In addition, Oracle will monitor the servers and manage the operating and database systems. DPU will pay a fixed monthly fee to Oracle for these services.

Justification/Urgency:

Oracle professional, hosting, and managed services, as well as licensing, software, and maintenance are vital for DPU operations to provide accurate information to our customers.

Anticipated Costs and funding source:

Funds for the first year will be covered from the general operating funds from CWD and CPP. Appropriations will be made annually from free balance for years 2 and 3.
