AN EMERGENCY ORDINANCE

Authorizing the Director of Finance to enter into an agreement with College Now Greater Cleveland, Inc., as fiscal agent to Say Yes Cleveland, for family support specialist services for students attending to the Cleveland Metropolitan School District and its partner schools in Cleveland, for a period of approximately four months.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Finance is authorized to enter into an agreement with College Now Greater Cleveland, Inc., as fiscal agent to Say Yes Cleveland, for family support specialist services for students attending the Cleveland Metropolitan School District and its partner schools in Cleveland, for a period of approximately four months.

Section 2. That the agreement and other appropriate documents needed to complete the transaction authorized by this legislation shall be prepared by the Director of Law.

Section 3. That the Director of Finance shall provide quarterly updates to all members of Council from Say Yes Cleveland on the status of Family Support Specialist funding, along with any relevant metrics on the program, who is serviced, and outcomes, for a period of three years after execution of the contract.

~~Section 3~~ Section 4. That the cost of the agreement shall not exceed \$600,000 and shall be paid from American Rescue Plan Act payments received by the City, if eligible, or from other funds approved the Director of Finance.

~~Section 4~~ Section 5. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
