WHEREAS, this Council objected to the transfer of location of a D5 Liquor Permit to Kizella, LLC., DBA: Magic City Lounge, 14201 Harvard Avenue, Cleveland, Ohio 44128, Permanent No. 46878540001 by Resolution No. 16-2025, adopted by the Council on January 6, 2025; and

WHEREAS, this Council wishes to withdraw its objection to the above permit and consents to said permit; and

WHEREAS, this resolution constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

#### BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLEVELAND:

**Section 1.** That objection to the transfer of location of a D5 Liquor Permit to Kizella, LLC., DBA: Magic City Lounge, 14201 Harvard Avenue, Cleveland, Ohio 44128, Permanent No. 46878540001, be and the same is hereby withdrawn and Resolution No. 16-2025, containing such objection, be and the same is hereby repealed and that this Council consents to the immediate permit thereof.

**Section 2.** That this resolution is hereby declared to be an emergency measure and provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
