

Division of Cleveland Public Power

Request for Legislation

To authorize the Director of Public Utilities to enter into one or more requirement contracts for the purchase of duct line, street lighting bases and pull boxes; labor and materials necessary to install, repair, replace or maintain the duct line, street lighting bases and pull boxes, and other related incidentals for the Division of Cleveland Public Power for a period of two years, with two one-year options to renew.

Background/Purpose:

Labor and material to install, maintain and repair duct lines, street lighting bases and pull boxes is necessary to maintain the integrity and reliability of the Cleveland Public Power infrastructure at ground level and underground. Having this work completed by contractors provides on-going as-needed services to CPP which would require hiring additional personnel and purchasing capital equipment by the City of Cleveland. This is a continuation of an existing contract.

Scope of Work/Commodities/Services:

The scope of work to consist of, but is not limited to, excavation, pavement removal and replacement, curb removal and replacement, under drains, sub base, installation and/or replacement of miscellaneous underground duct lines, manholes, pull boxes, street lighting pole bases and adjustment of castings to grade.

Justification/Urgency:

Legislation is requested to provide uninterrupted work on the city’s underground duct line for the Division of Cleveland Public Power by the 3rd quarter of 2019.

Anticipated Costs and funding source:

CPP General Operating Funds \$1,200,000.00 for 2 years.

Schedule or Term of Contract:

Legislation is to lead to one or more Requirement contracts for a term of two years with 2-one year Options for Renewal.
