## Ordinance No. 1412-17

Council Members Zone and Kelley (by departmental request)

#### **AN EMERGENCY ORDINANCE**

Authorizing the Director of Public Safety to apply for and accept a grant from the United States Department of Homeland Security for the FY 2016 Assistance to Firefighters Grant; and authorizing the purchase by one or more requirement contracts of materials, equipment, supplies, services, and training needed to implement the grant, including thermal imaging cameras, for the Division of Fire, Department of Public Safety.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Public Safety is authorized to apply for and accept a grant in the amount of \$286,173, and any other funds that become available during the grant term, from United States Department of Homeland Security to conduct the FY 2016 Assistance to Firefighters Grant; that the Director of Public Safety is authorized to file all papers and execute all documents necessary to receive the funds under the grant; and that the funds are appropriated for the purposes set forth in the award package and application for the grant contained in the file described below.

Section 2. That the award package and application for the grant, File No. 1412-17-A, made a part of this ordinance as if fully rewritten, including the obligation of the City of Cleveland to provide cash matching funds in the amount of \$28,617 from Fund No. 01-6003-6397, is approved in all respects and shall not be changed without additional legislative authority. (RQS 6001, RL 2017-103)

Section 3. That the Director of Public Safety is authorized to make one or more written requirement contracts under the Charter and the Codified Ordinances of Cleveland, Ohio, 1976, for the requirements during the grant period of the necessary items of materials, equipment, supplies, services, and training needed to implement the grant, including thermal imaging cameras, in the approximate amount as purchased during the preceding term, to be purchased by the Commissioner of Purchases and Supplies on a unit basis for the Department of Public Safety. Bids shall be taken in a manner that permits an award to be made for all items as a single contract, or by

separate contract for each or any combination of the items as the Board of Control

determines. Alternate bids for a period less than the specified term may be taken if

desired by the Commissioner of Purchases and Supplies until provision is made for the

requirements for the entire term.

That the costs of the contract or contracts shall be charged against Section 4.

the proper appropriation accounts and the Director of Finance shall certify the amount

of any purchase under the contract, each of which purchases shall be made on order of

the Commissioner of Purchases and Supplies by a delivery order issued against the

contract or contracts and certified by the Director of Finance.

Section 5. That under Section 108(b) of the Charter, the purchases authorized

by this ordinance may be made through cooperative arrangements with other

governmental agencies. The Director of Public Safety may sign all documents that are

necessary to make the purchases, and may enter into one or more contracts with the

vendors selected through that cooperative process.

That the Director of Public Safety shall have the authority to extend Section 6.

the term of the grant if the extension does not involve an increase in the dollar amount

of the grant specified above.

Section 7. That this ordinance is declared to be an emergency measure and,

provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest

period allowed by law.
