

Ordinance No. 77-2026

AN EMERGENCY ORDINANCE

Consenting and approving the issuance of a permit for the Westside Catholic Center Pancake Run event, on June 6, 2026, managed by Hermes Sports & Events.

FOR PASSAGE
February 2, 2026

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That pursuant to Section 411.06 of the Codified Ordinances of Cleveland, Ohio 1976, this Council consents to and approves the Westside Catholic Center Pancake Run event, on June 6, 2026, managed by Hermes Sports & Events; START: on West 32nd Street in front of West Side Catholic Center (3135 Lorain Avenue) - head south on West 32nd Street - right on Chatham Avenue - left on West 33rd Street - left on Monroe Avenue - right on West 25th Street - sharp left onto Columbus Road - veer left onto Red Line Greenway APT - turnaround on APT - right on Columbus Road - right on West 25th Street - left on Monroe Avenue - right on West 30th Street - right on Chatham Avenue - left on West 32nd Street – FINISH: on West 32nd Street in front of West Side Catholic Center (3135 Lorain Avenue); provided that the applicant sponsor shall meet all the requirements of Section 411.05 of the Codified Ordinances of Cleveland, Ohio, 1976. Streets may be closed as determined by the Chief of Police and safety forces as may be necessary in order to protect the participants in the event. Said permit shall further provide that the City of Cleveland shall be fully indemnified from any and all liability resulting from the issuance of the same, to the extent and in form satisfactory to the Director of Law.

Section 2. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
