

Ordinance No. 1447-2025

AN EMERGENCY ORDINANCE

To establish subfunds 65 SF 011 and 10 SF 114 for the deposit and remittance of New Community Authority parking charges at certain city-owned parking facilities and to transfer any such collected charges less any City adjustments into the appropriate new subfund.

WHEREAS, under the authority of Ordinance No. 1061-2024, passed March 3, 2025, the City, through its Directors of Public Works and Port Control, and North Coast Waterfront New Community Authority (“NCA”) entered into City Contract #CT-7001-ST2025*0021 for the City, on behalf of the NCA to collect, and subsequently remit to the NCA, certain parking charges at the following City-owned parking facilities: the Dock Lots, East 9th Street Pier Lot, North Marginal Lot, North Coast Municipal Parking Lot, and Willard Park Garage (collectively, “NCA Parking Charges”); and

WHEREAS, for accounting purposes, new subfunds are necessary for the deposit and remittance of NCA Parking Charges collected by the Division of Parking Facilities and the Division of Harbors less any City adjustments; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That, subject to any approvals required by law, subfunds 65 SF 011 and 10 SF 114 are established for the Division of Parking Facilities and the Division of Harbors, respectively, for the deposit and remittance of NCA Parking Charges less any City adjustments

Section 2. That the Director of Finance is authorized to transfer any NCA Parking Charges deposited into other City subfunds to the appropriate subfund described in Section 1 of this ordinance.

Section 3. That it is found and determined that all formal actions of the Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including all lawful ordinances and any applicable provisions of Section 121.22 of the Revised Code.

Section 4. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
