Background/Purpose:

To provide service connectivity to locations outside of Cuyahoga County which are beyond the AT&T service area. The service includes primary and backup communications for SCADA control, security cameras and telephones at multiple locations of outlying water towers, pump stations, and facilities located in areas which are outside of Cuyahoga County and beyond the AT&T service area. Legislation is to lead to a new direct award contract for the term of three (3) years.

Scope of Work/Commodities/Services:

The resultant three-year contract would allow us to continue services from Windstream Communications, LLC and to pay monthly invoices for our current services and any additional services as needed until February 6, 2028.

Justification/Urgency:

Windstream Communications, LLC provides connectivity to locations that are outside of the AT&T service area. This connectivity is critical to the security and safety to our Water system. This services our outlying water towers, pump stations, and facilities. DPU wishes to continue these services.

This new contract will need to be in place by February 6th, 2025 to ensure services continue uninterrupted.
