## **REGIONAL MANAGER OF WASTE COLLECTION**

### Duties:

Under administrative direction, manages, plans, organizes, and directs personnel within established Waste Collection regions of the City of Cleveland. Performs data analysis and development. Develops work rules. Inspects solid waste/recycle collection routes, the processing of refuse and recyclables collected, and/or the operations of a Transfer Station. Utilizes a computer and software for work management, GPS tracking, email communications, and the creation of spreadsheets, forms, letters, etc.

Interprets collective bargaining contracts to ensure that they are being correctly applied to all personnel and situations as they arise. Plans and schedules work assignments. Establishes performance measures and monitors to identify issues and to develop strategic improvements.

Inspects waste collection routes and equipment. Investigates complaints. Conducts safety briefings and training. Initiates labor relations and human resources actions and serves as a hearing officer in formal disciplinary procedures. Performs other job-related duties as required.

#### Minimum Qualifications:

A High School Diploma or GED is required. An Associate's Degree in Engineering, Science, Business, Finance, Environmental Science, or closely related field from an accredited college or university is required. Two years of full time paid management experience in public works operations is required. (Substitution: Two years of experience within a waste collection operation may substitute for each year of college lacking.) Must be computer proficient especially with Microsoft Office Suites. A valid State of Ohio Driver's License is required. The following are preferred: Two years of experience in waste collection operations or similar field; Experience with route optimization software; Ability to communicate clearly and effectively verbally and in writing; proven leadership abilities in working with a diverse staff.

The pay band recommended salary info is based upon independent research conducted by the Department of Human Resources against the proposed pay-band from the Department of Public Works for validation purposes. This position is considered professional in nature. We are in agreement with the Department's suggested pay band, based on comprehensive research from the following external entities:
