Ordinance No. 809-2024

AN EMERGENCY ORDINANCE

To change the name of a portion of West Roadway to Sherwin Way.

By Council Members McCormack, Bishop, Hairston and Griffin (by departmental request)

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That, notwithstanding and as an exception to the Codified Ordinances of Cleveland, Ohio, 1976, the name of a portion of West Roadway from the northerly line of Superior Avenue (132'), extending northerly, along the westerly line of West Roadway, and 80.00 feet easterly therefrom, to the easterly prolongation of the southerly line of Frankfort Avenue (45') shall be changed to Sherwin Way.

Section 2. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
