# Ordinance No. 1375-17

#### **AN EMERGENCY ORDINANCE**

To amend Sections 1 and 2 of Ordinance No. 708-17, passed July 12, 2017, relating to a grant from the Ohio Office Criminal Justice Services for the 2016 Ohio Drug Law Enforcement Fund grant.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Sections 1 and 2 of Ordinance No. 708-17, passed July 12, 2017, are amended to read as follows:

Section 1. That the Director of Public Safety is authorized to apply for and accept a grant in the approximate amount of \$427,608.58, and any other funds that may become available during the grant term from the Ohio Office of Criminal Justice Services to conduct the 2016 Ohio Drug Law Enforcement Fund Grant; that the Director is authorized to file all papers and execute all documents necessary to receive the funds under the grant; and that the funds are appropriated for the purposes described in the application for the grant contained in the file described below.

Section 2. That the application for the grant, File No. 708-17-A, made a part of this ordinance as if fully rewritten, as presented to the Finance Committee of this Council at the public hearing on this legislation, including the obligation of the City of Cleveland to provide cash matching funds in the amount of \$142,536.21 from Fund No. 10 SF 026, is approved in all respects and shall not be changed without additional legislative authority. Section 2. That existing Sections 1 and 2 of Ordinance No. 708-17, passed July 12, 2017, are repealed.

<u>Section 3.</u> That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
