

Ordinance No. 179-2026

AN EMERGENCY ORDINANCE

Consenting and approving the issuance of a permit for the Patrick Joyce Fund 5K on July 18, 2026, managed by Run the Land.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That pursuant to Section 411.06 of the Codified Ordinances of Cleveland, Ohio 1976, this Council consents to and approves the holding of the Patrick Joyce Fund 5K on July 18, 2026; START: Rocky River Drive immediately north of Lorain Avenue; north on Rocky River Drive; west on Amber Drive; around cul-de-sac & east on Amber Drive; south on Rocky River Drive; west on Claire Avenue; east on Marquis Avenue; south on Rocky River Drive; east on Lucille Avenue; south on West 165th Street; west on Dartmouth Avenue; south on West 169th Street; east on Ferndale Avenue; south on West 165th Street; west on Lorain Avenue; south on West 168th Street; west on Albers Avenue; FINISH: Albers Avenue at City Lot Entrance; provided that the applicant sponsor shall meet all the requirements of Section 411.05 of the Codified Ordinances of Cleveland, Ohio, 1976. Streets may be closed as determined by the Chief of Police and safety forces as may be necessary in order to protect the participants in the event. Said permit shall further provide that the City of Cleveland shall be fully indemnified from any and all liability resulting from the issuance of the same, to the extent and in form satisfactory to the Director of Law.

Section 2. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
