**To Apply, Accept and Expend State Capital Improvement Funds (Issue I) Year 2018**

**Ordinance No:** 1162-17

**Projects:** To apply and accept an Issue I Grant for the following projects:

1. Clark Ave. Rehabilitation (West 41<sup>st</sup> St. to Quigley), PID 104932 (construction)
2. East 105<sup>th</sup> Rehabilitation (East Blvd. to Greenlawn Ave.) (Design)
3. East 131<sup>st</sup> St. Rehabilitation (Miles Ave. to Union Ave.) (Design)
4. Fulton Rd. Reconstruction (Clark Ave. to Lorain Ave.) (Design & Construction)
5. Harvard Ave. Rehabilitation (Lee Rd. to Evanston/East Corp. Line) (Design & Construction)
6. Lorain Ave. Rehabilitation (West 117<sup>th</sup> St. to W 65<sup>th</sup> St.), PID 89248 (Construction)

**Scope of Work** The roadway work includes street rehabilitation; replacement of curbs, sidewalks and driveway aprons as needed, ADA compliant ramps. Non Standard Catch Basins will be removed and replaced and additional catch basins will be placed in low points. Bike lanes/sharrows are part of each application. Fulton pavement will be removed and replaced with concrete.

**Legislation Purpose:** This legislation will authorize the Mayor to apply for, accept and expend Ohio Public Works Commission (OPWC) State Capital Improvement Funds (Issue I) for the above projects. Local share will be authorized from any and all funds by the Director of Finance. Clark received design funding last year and construction grant will be requested this year. Fulton and Harvard are design and construction grant requests. East 105<sup>th</sup> and East 131<sup>st</sup> are design grant requests. Lorain is construction grant request to supplement local share for federal funded asphalt paving project. Legislation will also authorize consent and cause payment to ODOT for Clark Avenue and Lorain Avenue.
