AN EMERGENCY ORDINANCE

Authorizing the Director of Community Development to apply for and accept a Clean Ohio Fund – Green Space Conservation Program grant from the Ohio Public Works Commission for construction of the Morgana Bluff Nature Preserve and Learning Center; and authorizing the Director to enter into one or more contracts with the Boys & Girls Clubs of Cleveland, or its designee, to implement the grant project.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Community Development is authorized to apply for and accept a Clean Ohio Fund – Green Space Conservation Program grant in an amount up to \$250,000, from the Ohio Public Works Commission for construction of the Morgana Bluff Nature Preserve and Learning Center, to be used to implement the project as described in the executive summary below; that the Director is authorized to file all papers and execute all documents necessary to receive the funds under the grant; and that the funds are appropriated for the purposes described in the executive summary for the grant contained in the file described below and in any subsequent grant amendments, which amendments will be filed with Council.

- Section 2. That the summary for the grant, File No. 1242-17-A, made a part of this ordinance as if fully rewritten, is approved in all respects and shall not be changed without additional legislative authority.
- Section 3. That the Director of Community Development is authorized to enter into one or more contracts with the Boys & Girls Clubs of Cleveland, or its designee, to implement the grant project.
- <u>Section 4.</u> That the contract or contracts authorized by this ordinance shall be prepared by the Director of Law.
- <u>Section 5.</u> That the Director of Community Development is authorized to enter into any other agreement necessary to implement the grant project.
- <u>Section 6.</u> That the cost of the contract or contracts authorized will be paid from the fund or subfunds that are credited the proceeds of the grant accepted under this ordinance.
- <u>Section 7.</u> That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
