WHEREAS, this Council wishes to withdraw its objection to the above permit and consents to said permit; and

WHEREAS, this resolution constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

### BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLEVELAND:

**Section 1.** That objection to the transfer of ownership of a C1 and C2 Liquor Permit to Michael Miyako Boyer, LLC, DBA 7 Eleven Store 36237A, 1035 East 185<sup>th</sup> Street, Cleveland, Ohio 44119, Permit No. 59034330005 by Resolution No. 602-2019 adopted by the Council on May 6, 2019, containing such objection, be and the same is hereby repealed and that this Council consents to the immediate permit thereof.

**Section 2.** That this resolution is hereby declared to be an emergency measure and provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its adoption and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
