The purpose of this letter is to apprise your office that Famicos Foundation plans to be the developer and general partner of a residential rental development located in or within a one-half mile radius of your political jurisdiction, and was awarded funding to utilize the multifamily funding programs of the Ohio Housing Finance Agency (OHFA) for the development of this property.

Famicos Foundation is planning a scattered-site, single family lease-purchase project to be located in a well-defined area of the "Circle North" strategic investment area. The project will utilize 9% Low Income Housing Tax Credits, which were received during OHFA's February 2018, tax credit application round. The project will consist of 30 three bedroom houses to be rented to families earning up to 60% of Area Median Income. After a 15-year rental period, the houses will be sold to the residents or other qualifying buyers. All houses will be new-construction, built on "Land Bank" parcels purchased from both the City of Cleveland and Cuyahoga County.

The proposed development will be financed with low-income housing tax credits and a conventional first mortgage.
