# Ordinance No. 835-2024 AS AMENDED

### **AN EMERGENCY ORDINANCE**

Authorizing the Executive Director of the Community Police Commission to enter into one or more contracts with the United Black Fund of Greater Cleveland for grant management services, for a period of one year with one option to renew for an additional year, exercisable by the Executive Director of the Community Police Commission exercisable through additional legislative authority-.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Executive Director of the Community Police Commission is authorized to enter into one or more contracts with the United Black Fund of Greater Cleveland for grant management services, on the basis of its proposal dated June 17, 2024 and updated on August 1, 2024, for the Executive Director of the Community Police Commission, for a period of one year with one option to renew for an additional year, exercisable by the Executive Director of the Community Police Commission exercisable through additional legislative authority-.

Section 2. That under Section 108(b) of the Charter, the purchases and/or services authorized by this ordinance may be made through cooperative arrangements with other governmental agencies. The Executive Director of the Community Police Commission, may sign all documents that are necessary to make the purchases and/or obtain such services, and may enter into one or more contracts with the vendors and/or consultants selected through that cooperative process.

Section 2a. That the Executive Director of the Community Police Commission shall provide all members of Council a quarterly report from the United Black Fund of Greater Cleveland regarding the groups that are funded and their status.

Section 3. The contract or contracts shall be paid from Fund No. 01-0122-6376. (RQS 0122, RL 2024-85).

<u>Section 4.</u> That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
