

**Cleveland Department of Public Health****Ordinance No. 602-2025**

**Cleveland Office of Minority Health  
Background/Purpose**

This legislation authorizes the Director of Public Health to apply for and accept funding from the Ohio Commission on Minority Health (OCMH) to continue operations of the Cleveland Office of Minority Health and to enter into contracts to fulfill the obligations of the office as expressed in its grant applications.

This legislation also authorizes the Director of Public Health to accept any additional funds that may become available, broadening the scope of the Office of Minority Health service. The Director of Public Health enters into contracts as needed to implement the grant as described in the file.

The OCMH announced the availability of funds to support grants for the continuation of local offices in Cleveland, Columbus, Dayton, Summit County, Toledo and Youngstown. The OCMH requirement is to establish each local office in a local health department. Funding eligibility is limited to City/Combined Health Districts. The Commission accepts one applicant per city.

**Mission:**

The Cleveland Office of Minority Health (COMH) is a project of the Ohio Commission on Minority Health. Councilman Kevin Conwell introduced legislation in 2007, formally establishing the office by City ordinance. The work of the Cleveland Office of Minority Health, as required by the Ohio Commission on Minority Health, includes the following to reduce health disparities:

- Monitoring and reporting the health status of minority populations
- Informing, educating, and empowering people
- Mobilizing community partnerships and actions
- Developing policies and plans to support health efforts

The purpose of the office is to advance health equity and work collaboratively with community partners to reduce health disparities among minoritized and marginalized populations, including but not limited to, African Americans, Hispanic/Latinos, Asians, Native Americans, persons living in poverty and the LGBTIA+ communities.

The local offices of minority health work on emerging local issues such as infant mortality, food insecurity, lead poisoning, and air quality. By working with public and private partners, the Cleveland Department of Public Health creates a synergistic impact to negating health disparities in the community. Moreover, this approach promotes and advances the health equity agenda of the Cleveland Department of Public Health.

The Director collaborates with internal programs and offices to advance the work of the local office and leverage COMH resources to support ongoing community efforts.
