

Ordinance No. 101-2026

AN EMERGENCY ORDINANCE

Consenting and approving the issuance of a permit for the UCP of Greater Cleveland 5K on May 3, 2026, managed by Hermes Sports & Events.

FOR PASSAGE
February 2, 2026

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That pursuant to Section 411.06 of the Codified Ordinances of Cleveland, Ohio 1976, this Council consents to and approves the holding of the UCP of Greater Cleveland 5K on May 3, 2026, managed by Hermes Sports & Events;

START: United Cerebral Palsy of Greater Cleveland (UCP Cleveland) (10011 Euclid Avenue); head north on East 101 Street; East 101 Street turns into Ansel Road; turn right on Mt. Sinai Drive; turn left on East 105 Street; turn right towards Martin Luther King Jr. Drive; turn left on East 105 Street; turn left on Martin Luther King Jr. Drive; continue on Martin Luther King Jr. Drive; turnaround; follow Martin Luther King Jr. Drive back to East 105 Street; turn right to get on East 105 Street; turn right on Mt. Sinai Drive; turn left on Ansel Road; Ansel Road turns into East 101 Street; FINISH: Follow East 101 Street to arrive back at UCP of Greater Cleveland (10011 Euclid Avenue);;

provided that the applicant sponsor shall meet all the requirements of Section 411.05 of the Codified Ordinances of Cleveland, Ohio, 1976. Streets may be closed as determined by the Chief of Police and safety forces as may be necessary in order to protect the participants in the event. Said permit shall further provide that the City of Cleveland shall be fully indemnified from any and all liability resulting from the issuance of the same, to the extent and in form satisfactory to the Director of Law.

Section 2. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
