

Ordinance No. 738-10

AN ORDINANCE

Changing the Use District of land located at the northeast corner of Woodland Ave. and E. 75th St. to Open Space and Recreation (Map Change No.2322; Sheet No. 5).

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Use District of lands bounded and described as follows:

Beginning at the intersection of the centerline of Woodland Avenue with the Southeasterly prolongation of the centerline of the Pennsylvania Lines, LLC right-of-way as conveyed to Pennsylvania Lines, LLC by deed recorded in Auditor's File Number 200208200162 of Cuyahoga County Deed Records, said parcel also being known as Cuyahoga County's Permanent Parcel Number 124-07-002;

Thence Westerly along said centerline of Woodland Avenue to its intersection with the centerline of East 75th Street;

Thence Northerly along said centerline of East 75th Street to its intersection with the Northwesterly prolongation of said centerline of the Pennsylvania Lines, LLC right-of-way;

Thence Southeasterly along said centerline of the Pennsylvania Lines, LLC right-of-way, its Northwesterly prolongation and its said Southeasterly prolongation to the principal place of beginning

and as shaded on the attached map is changed to an Open Space and Recreation District.

Section 2. That the changed designation of lands described in Section 1 shall be identified as Map Change No. 2322, Sheet No. 5 and shall be made upon the Building Zone Maps of the City of Cleveland on file in the office of the Clerk of Council and on file in the office of the City Planning Commission by the appropriate person designated for this purpose by the City Planning Commission

Section 3. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
