The purpose of this letter is to apprise your office that CHN Housing Partners (CHN) plans to be the owner of Cleveland Scholar House Inc., the general partner of a residential rental development located in or within a one-half mile radius of your political jurisdiction, and will submit an application to utilize the multifamily funding programs of the Ohio Housing Finance Agency (OHFA) for the development of this property.

CHN intends to submit a 2021 Low Income Housing Tax Credit application to the Ohio Housing Finance Agency in February 2021. If selected for funding, Cleveland Scholar House will be an approximately forty (40) unit midrise new construction building located in Cleveland's Central neighborhood.
