

Request for Legislation

Request for the additional legislative authority required under Ordinance No. 416-17 to exercise the one-year option to renew requirement contract RC2018-32 with Chemtron Corporation. This requirement contract is to provide labor and materials for analysis, identification, storage, remediation, transportation, clean-up, recycling, and disposal of various chemicals, hazardous waste products, and other non-hazardous and recyclable waste materials and required training for employees of the Divisions of Water, Water Pollution Control and Cleveland Public Power.

Background/Purpose:

The day-to-day activities of CWD, CPP and WPC result in the generation of hazardous and non-hazardous waste. The Environmental Protection Agency (EPA) and Department of Transportation (DOT) regulate how hazardous and non-hazardous wastes must be handled, stored, transported, disposed of and/or recycled. In addition, Department of Public Utilities employees involved in these operations must be trained in accordance with EPA and DOT regulations. It is necessary for the Department to hire an appropriately licensed company to perform hazardous and non-hazardous waste disposal and recycling activities. The requested services are essential for regulatory compliance regarding the generation, minimization, handling, disposal, and recycling of hazardous and non-hazardous wastes.

Continuance of this contract will assure that the Department of Public Utilities meets EPA regulations regarding waste management.

Tasks that have been performed on the current contract include:

1. Non-Hazardous Waste Disposal (Batteries, Light Bulbs, Used Oil, 'Sharps' Containers, etc.),
2. Hazardous Waste Disposal (Waste Sodium Hydroxide, Waste Potassium Permanganate, Asbestos Containing Materials, etc.),
3. Emergency Response Across DPU Facilities,
4. Cleaning Services Across DPU Facilities,
5. Providing Drums, Totes, and other Waste Packaging Materials, and
6. Labor (Waste Analyzation / Laboratory Analysis, Waste Pickup, Emergency Response, etc.)

Scope of Work/Commodities/Services:

Chemtron Corporation will continue to provide labor and materials necessary for analysis, identification, storage, remediation, transportation, clean-up, recycling and disposal of various chemicals, hazardous wastes, products and other non-hazardous and recyclable waste for the first one-year option to renew.

Justification/Urgency:

These services must be provided by licensed hazardous waste companies. The current contract expires March 12, 2020. If there is a lapse between contracts, the Department could face potential non-compliance with EPA regulations and associated fines and violations.

Anticipated Costs and Funding Source:

The estimated cost of the first one-year option to renew is \$280,000.00. Funding will come from the operating funds of the Divisions of Water 52 001, Cleveland Public Power 58 001, and Water Pollution Control 54 001.

Breakdown per Division:

- 1. Division of Water - \$200,000.00
- 2. Cleveland Public Power - \$50,000.00
- 3. Water Pollution Control - \$30,000.00

Schedule or Term of Contract:

The request is to exercise the first one-year option to renew.
