

Division Cleveland Public Power

Request for Legislation

An Ordinance authorizing the Director of the Department of Public Utilities to enter into one or more requirement contracts for the purchase of Labor and Materials to Paint Poles and Other Street Side Elements for the Division of Cleveland Public Power. Legislation to lead to a requirement contract or contracts for a period up to two (2) years.

Background/Purpose:

Cleveland Public Power is responsible for painting streetlight poles and other street side elements, such as, traffic signal poles, control cabinets, pedestrian signal poles, pole bases and signposts. The ordinance will authorize the Director of Public Utilities to enter into one or more requirement contracts for the purchase of labor and materials needed to provide this service.

Scope of Work/Commodities/Services:

The scope of work includes, but is not limited to providing the labor, materials and equipment to clean, prime and finish coat metal and fiberglass poles of various sizes and styles, lighting mast arms, vent pipes, traffic signal mast arms, traffic control cabinets, pedestrian signal poles and bases, guardrails, bollard, and sign posts. The work scope also includes removal of any idle equipment or hardware as directed by CPP and removal/replacement of banners, signs or other ornamentation.

Justification/Urgency:

The work provided under this contract is required for routine maintenance for the poles and other elements in the City's right of ways. The current contract will expire November 11, 2020.

Anticipated Costs and funding source:

CPP's general operating fund will be used for this contract. The estimated amount of the two-year contract is \$150,000.00.

Schedule or Term of Contract:

Legislation is to lead to one or more requirement contracts for up to a period of two (2) years
