#### AN EMERGENCY ORDINANCE

Amending the Title and Section 1 of Ordinance No. 732-2019, passed June 3, 2019, as it pertains to the United Way of Greater Cleveland's Lead Safe Summit Expo through the use of Wards 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 12, 13, 14, 15, 16 and 17 Casino Revenue Funds.

FOR PASSAGE November 4, 2020

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Title and Section 1 of Ordinance No. 732-2019, passed June 3, 2019, are hereby amended to read as follows:

An emergency ordinance authorizing the Director of the Department of Community Development Public Health to enter into agreement with United Way of Greater Cleveland for the Lead Safe Summit Expo through the use of Wards 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 12, 13, 14, 15, 16, and 17 Casino Revenue Funds.

Section 1. That the Director of the Department of Community Development Public Health is hereby authorized to enter into agreement effective June 5, 2019, with the United Way of Greater Cleveland for the Lead Safe Summit Expo for the public purpose of providing educational programming on lead poisoning prevention to city of Cleveland residents through the use of Wards 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 12, 13, 14, 15, 16, and 17 Casino Revenue Funds.

Section 2. That the Title and Section 1 of Ordinance No. 732-2019 passed June 3, 2019, are hereby repealed.

Section 3. That the Director of Law shall prepare and approve said contract and that the contract shall contain such terms and provisions as he deems necessary to protect the City's interest.

<u>Section 4.</u> That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
