## AN EMERGENCY ORDINANCE

Authorizing the Director of Finance to exercise the second option to renew Contract No. RCWS 2018-1 with AT&T Mobility National Accounts LLC for paging equipment, cellular devices and data services, and for wireless connectivity and equipment, and various related products and services, maintenance, training, support and monthly fees and charges for citywide use.

WHEREAS, under the authority of Ordinance No. 716-17, passed July 12, 2017, the Director of Finance entered into Contract No. RCWS 2018-1 with AT&T Mobility National Accounts LLC (“AT&T”) for paging equipment, cellular devices and data services, and for wireless connectivity and equipment, and various related products and services, maintenance, training, support and monthly fees and charges for citywide use; and

WHEREAS, Ordinance No. 716-17 requires further legislation before exercising the second option to renew on this contract; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Finance is authorized to exercise the second option to renew Contract No. RCWS 2018-1 with AT&T for the requirements for an additional year for paging equipment, cellular devices and data services, and for wireless connectivity and equipment, and various related products and services, maintenance, training, support and monthly fees and charges for citywide use. This ordinance constitutes the additional legislative authority required by Ordinance No. 716-17 to exercise this option.

Section 2. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
