AN EMERGENCY ORDINANCE

To amend Sections 45 and 55 of Ordinance No. 194-2021, passed March 29, 2021, as amended, relating to salaries for various classifications.

FOR PASSAGE
September 18, 2023

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the following Sections:

Section 45 of Ordinance No. 194-2021, passed March 29, 2021, as amended by Ordinance No. 1073-2021, passed November 29, 2021, Ordinance No. 94-2022, passed March 21, 2022, Ordinance No. 523-2023, passed April 24, 2023, and Ordinance No. 697-2023, passed June 5, 2023, and

Section 55 of Ordinance No. 194-2021, passed March 29, 2021, as amended by Ordinance No. 821-2022, passed August 10, 2022,

are amended to read as follows:

Section 45. Part-Time/Seasonal Group

That salaries ~~and compensation~~ in the following classifications shall be fixed by the appointing authority in accordance with the schedule appearing after each classification:

Section 55. Cleveland Police Patrolmen’s Association (CPPA) -- (Non-Civilian) Division of Police. The annual salaries of persons appointed to the ranks of patrol officer shall be fixed by the appointing authority within the limits established in the following schedules:

Section 55 of Ordinance No. 194-2021, passed March 29, 2021, as amended by Ordinance No. 821-2022, passed August 10, 2022,

are repealed.

Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
