# Ordinance No. 1189-2021

## **AN EMERGENCY ORDINANCE**

To amend Section 13 of Ordinance No. 753-2021, passed September 20, 2021, relating to applying for and accepting a grant from the Cleveland Foundation for the development of the African American Cultural Gardens.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Section 13 of Ordinance No. 753-2021, passed September 20, 2021, is amended to read as follows:

Section 13. That the cost of this ordinance shall be paid from the fund or fund to which are credited the proceeds of the grant accepted in this ordinance or any gifts or grants received for the purposes of the ordinance (RQS 7001, RLA 2021 2021-51) "and from any other funds (\$175,000 – Fund No. 01-001) that are appropriated in 2022 for this purpose as determined by the Director of Finance."

Section 2. That existing Section 13 of Ordinance No. 753-2021, passed September 20, 2021, is repealed.

Section 3. That this ordinance is hereby declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
