The purpose of this letter is to apprise your office that Park Village Cleveland, Inc. plans to be the general partner of a residential rental development located in or within a one-half mile radius of your political jurisdiction and will submit an application to utilize the multifamily funding programs of the Ohio Housing Finance Agency (OHFA) for the development of this property.

Park Village is an existing 75-unit multifamily development for families, located at 9221 Hough Avenue, Cleveland, Ohio. The property offers a mix of 2-, 3- and 4-bedroom apartments in eight residential buildings affordable to households at 30%, 50% and 60% of area median income. All units are subject to a rental assistance contract making them affordable regardless of the OHFA targeting. Famicos, which has owned the property through a subsidiary since 2001, plans a substantial rehabilitation of both the apartments and the community building to preserve this critical subsidized asset.

The proposed development will be financed with conventional bank debt, funding from the City of Cleveland, a seller note and equity from the sale of housing credits partially bridged by a Housing Development Loan from the OHFA.

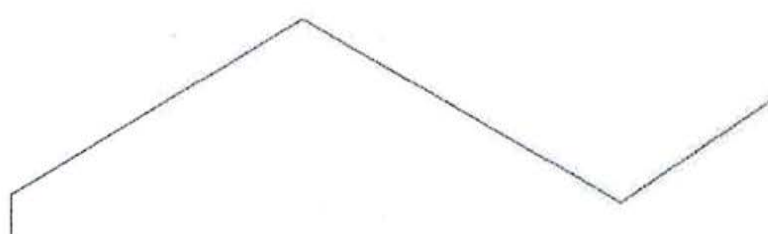
