AN EMERGENCY ORDINANCE

To amend the title and Sections 2 and 3 of Ordinance No. 992-17, passed August 16, 2017, relating to the steam boilers at the West Side Market.

FOR PASSAGE September 18, 2017

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the title and Sections 2 and 3 of Ordinance No. 992-17, passed August 16, 2017, are amended to read as follows:

An Emergency Ordinance ratifying and approving the emergency purchase of steam boilers for the West Side Market; and authorizing the <u>Director of Capital Projects or Public Works</u>, as appropriate, to enter into one or more contracts with <u>Eagle Mechanical</u>, <u>LLC</u> for the <u>immediate</u> purchase of the labor, <u>equipment</u>, and materials necessary to install the new boilers and the demolition and removal of existing ones, for the Office of Capital Projects or Department of Public Works, as appropriate.

Section 2. That the Director of Capital Projects or Public Works, as appropriate, is authorized to make <u>one or more</u> written contracts <u>with Eagle Mechanical, LLC on the basis of its proposal dated September 11, 2017, for the immediate purchase of labor, equipment, and materials necessary for the demolition and removal of the existing boilers and for the labor, equipment, and materials necessary to install the new boilers, to be purchased by the Commissioner of Purchases and Supplies, for a gross price for the Office of Capital Projects or Public Works, as appropriate.</u>

Section 3. That the cost of the contract authorized shall be paid from Fund Nos. 20 SF 516, 20 SF 523, 20 SF 535, 20 SF 538, 20 SF 544, 20 SF 552, 20 SF 558, 20 SF 561, 20 SF 565, 20 SF 566, 20 SF 572, 20 SF 573, 20 SF 578, and any and all funds approved by the Director of Finance. (RQS 0103, RLA 2017-37)

Section 2. That the existing title and Sections 2 and 3 of Ordinance No. 992-

17, passed August 16, 2017, are repealed.

<u>Section 3.</u> That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
