AN EMERGENCY ORDINANCE

To amend Sections 2 and 4 of Ordinance No. 119-2026, passed February 9, 2026, to change the name of Elements of Internal Movement Eternal Pull Inc. to Elements of Internal Movement Eternal Pull and to replace the File.

FOR PASSAGE
JULY 16, 2026

WHEREAS, under the authority of Ordinance No. 119-2026, passed February 9, 2026, the Director of Public Health was authorized to apply and accept a grant from Share Our Strength to conduct the Food Access Navigators program under Cultivating Cleveland's Next Generation projects and authorizing one or more contracts with East 66th Street Services Inc. and Elements of Internal Movement Eternal Pull Inc. to implement the grant; and

WHEREAS, the vendor identified in Ordinance No. 119-2026 as "Elements of Internal Movements Eternal Pull, Inc." was incorrectly cited, and the correct legal name of the vendor is "Elements of Internal Movements Eternal Pull," without the designation "Inc."; and

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That Sections 2 and 4 of Ordinance No. 119-2026, passed February 9, 2026, are amended to read as follows:

Section 2. That the summary for the grant, File No. ~~119-2026-A 119-2026-B~~, made a part of this ordinance as if fully rewritten, is approved in all respects and shall not be changed without additional legislative authority.

Section 4. That the Director of Public Health is authorized to enter into one or more contracts with East 66th Street Services Inc. and ~~Elements of Internal Movement Eternal Pull Inc.~~ Elements of Internal Movement Eternal Pull, or its legal successor corporation, to provide a total of four (4) youth navigators for project coordination and community education and for outreach materials, food, transportation and other services necessary to implement the grant as described in the file.

Section 2. That existing Sections 2 and 4 of Ordinance No. 119-2026, passed February 9, 2026, are repealed.

Section 3. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
