AN EMERGENCY ORDINANCE

Approving the collective bargaining agreement with the Plumbers Local 55 (Plumbers Inspectors) and to amend Section 21 of Ordinance No. 194-2021, passed March 29, 2021, as amended, relating to compensation for various classifications.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That under division (B) of Section 4117.10 of the Revised Code, this Council approves the collective bargaining agreement with Plumbers Local 55 (Plumbers Inspectors), under the terms contained in File No. 1518-2025-A, for the period from April 1, 2025 through March 31, 2028, and which provides, among other things, for an increase in the salaries and wages for members of the bargaining unit under the following schedule:

Section 2. That Section 21 of Ordinance No. 194-2021, passed March 29, 2021, is amended to read as follows:
