## AN EMERGENCY RESOLUTION

Declaring the intent to vacate a portion of West  
37<sup>th</sup> Place and West 36<sup>th</sup> Street.

WHEREAS, this Council is satisfied that there is good cause to vacate a portion of  
West 37<sup>th</sup> Place and West 36<sup>th</sup> Street, as described; and

WHEREAS, this resolution constitutes an emergency measure providing for the  
usual daily operation of a municipal department; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That this Council declares its intent to vacate a portion of the  
following described real property:

### **A portion of West 37<sup>th</sup> Place and West 36<sup>th</sup> Street**

Situated in the City of Cleveland, County of Cuyahoga and State of Ohio and known as  
being a portion of West 37<sup>th</sup> Place (10.00 feet wide) and West 36<sup>th</sup> Street (40.00 feet  
wide) in Sargent and Dixon's Re-Subdivision of part of Original Brooklyn Township Lot  
Number 52 as shown by the recorded plat in Volume 2 of Maps, Page 43 of Cuyahoga  
County Records, further described as follows:

Being all that portion of West 37<sup>th</sup> Place (10.00 feet wide) and West 36<sup>th</sup> Street (40.00  
feet wide) extending from the First Un-named Alley (width varies) South of Lorain  
Avenue and East of West 38<sup>th</sup> Street (Dedicated in Volume 342, Page 296 of the Court of  
Common Pleas) Southerly to the Easterly prolongation of the South line of Sublot 106 in  
said Sargent and Dixon's Re-Subdivision.

Legal Description approved by Greg Esber, Section Chief, Plats, Surveys and House  
Numbering Section.

Section 2. That this resolution is declared to be an emergency measure and,  
provided it receives the affirmative vote of two-thirds of all the members elected to  
Council, it shall take effect and be in force immediately upon its adoption and approval  
by the Mayor; otherwise it shall take effect and be in force from and after the earliest  
period allowed by law.
